Our goal is multi-faceted to raise awareness about leading construction and asset management technologies that could help reduce risk on site for the purposes of educating our clients and the insurance markets.

Product Description

OnSiteIQ is a visual documentation and risk assessment platform for construction projects. Our data collectors use a 360-degree camera to capture imagery as they perform walkthroughs of all accessible building floors on a weekly basis, then upload that media to the platform. Then the OnSiteIQ platform:

- Maps the walkthroughs to the associated building floor plans
- Provides 360-degree views at dozens of points along a walkthrough path
- Enables users to navigate back and forth in time to monitor progress and changes between walkthroughs for a single point
- Enable users to inspect and track the site for quality and safety

OnSiteIQ enables all stakeholders to inspect the site for quality to prevent any potential defect claims and disputes.



Safety

OnSiteIQ enables all stakeholders to inspect the site for safety, mitigating risk to prevent any potential injuries, fatalities, and unsafe conditions.

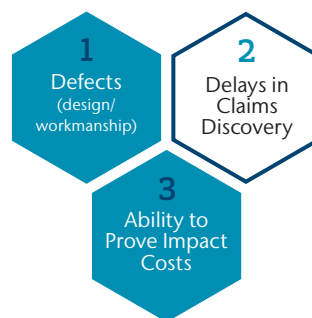


Progress
