

## SPORT ACCIDENT INSURANCE SUMMARY OF COVERAGES

<b>Eligibility:</b>	Amateur players, managers, coaches, trainers, officials executives <b>of Provincial Sport Organization (PSO)</b> . Volunteers and employees may be added if desired.
<b>When Covered:</b>	<p><b>PSO</b> Sanctioned and organized practices and competitions.</p> <p>Transportation to and from events (2 or more traveling together with a minimum distance of 100 km. traveled).</p> <p>Regularly scheduled commercial air lines, licensed charter.</p>
<b>Death (Principal sum):</b>	\$50,000 or \$25,000 (per policy documents)
<b>Loss Schedule:</b>	\$2,000 to 2 times principal sum
<b>Paralysis:</b>	2 x principal sum
<b>Prosthetics:</b>	\$3,000
<b>Blanket Medical Reimbursement:</b>	Same limit as principal sum.
<b>Rehabilitation:</b>	\$3,000
<b>Tuition:</b>	\$2,000
<b>Special Treatment Travel:</b>	\$1,000
<b>Out-of-Province:</b>	\$10,000
<b>Emergency Transportation (other than licensed ambulance):</b>	\$50
<b>Eyeglass and Contact Lenses:</b>	\$100
<b>Dental Accident:</b>	\$5,000 max. (limit varies for each PSO)
<b>Dentures, Artificial Teeth:</b>	\$200 (includes hearing aids)
<b>Fracture Indemnity:</b>	\$50 - \$500
<b>Aggregate:</b>	\$1,000,000
<b>Out-of-Country:</b>	Optional Add-on to extend cover for incidents that occur outside of Canada.
